Contributors

Professor Graham Donaldson is Professor in the Robert Owen Centre for Educational Change at the University of Glasgow. He has spent more than forty years in education and has worked in schools, universities and government, local and central. He was head of the Scottish Inspectorate from 2002–10.

Professor David Egan is Professor of Welsh Education Policy and Director of the Wales Centre for Equity in Education, University of Wales Trinity Saint David. He worked as Special Adviser for Education to the First Minister. He is a leading academic in the field of tackling the impact of poverty on educational attainment.

Professor John Furlong is Emeritus Professor of Education at the University of Oxford; he is also currently Adviser to the Welsh Government for Initial Teacher Education. He is author of two government reports on teacher education in Wales – the first published in 2006 (Furlong et al., 2006) and the second published in 2015 (Furlong, 2015).

Dr Russell Grigg is Executive Head of Research at the Wales Centre for Equity in Education, part of the University of Wales Trinity Saint David. He was previously Head of the South West Wales Centre for Teacher Education and is an Estyn inspector. His research interests are in the field of outstanding primary teaching, history of education and thinking skills.

Professor David Hopkins is Emeritus Professor at the Institute of Education, University College London and University of Nottingham, where he held the inaugural HSBC iNet Chair in International Leadership. He is currently Director of Education for the Bright Tribe Trust and a Trustee of Outward Bound and the charity Adventure Learning Schools (formed in 2009). David holds visiting professorships at the Catholic University of Santiago, the Chinese University of Hong Kong and the Universities of Cumbria, Edinburgh and Melbourne, and consults internationally on school reform.

Dr W. Gwyn Lewis was, until 2014, Senior Lecturer and Deputy Head of the School of Education at Bangor University, and is a former Research Collaborator in the ESRC Centre for Research on Bilingualism in Theory and Practice at Bangor University. His research interests include heritage/maintenance language education and immersion education, specifically within the context of Welsh-medium and bilingual education. His latest publications focus on translanguaging as an emerging and developing methodology in bilingual classrooms.

Professor Ken Reid has been working in the field of school attendance, truancy and behaviour for the last forty years. He works regularly with schools, Local Authorities and other organisations. He was the chair of the Welsh Assembly Government National Review into Behaviour and Attendance (NBAR). He is a regular correspondent for the *Times Education Supplement*, *Education Journal* and other periodicals, and appears regularly on national and local radio and television programmes.

Professor David Reynolds is Professor of Educational Effectiveness at the University of Southampton. He was involved in developing the study and practice of 'school effectiveness' and 'school improvement'. He is also currently a visiting professor at the Universities of Cyprus and Malaysia and has held a number of professorial positions at other universities in the UK and abroad.

Dr Jane Waters is Head of the South West Wales Centre of Teacher Education, based in the University of Wales Trinity Saint David. Having worked as a classroom teacher and then as director of an undergraduate Early Childhood Studies programme, she now works with students training to be teachers. Jane's research interests lie in early childhood education, adult-child interaction in educative spaces, young children's agency and voice, and young children's experiences of outdoor spaces.
