Contributors

Professor Mel Ainscow is Professor Emeritus of education at the University of Manchester. Currently he leads Schools Challenge Cymru. He is a consultant to UNESCO, working on international efforts to promote equity and inclusion globally. In the queen's 2012 New Year honours list he was made a CBE for services to education.

Professor Gary Beauchamp is Associate Dean (research) for the School of Education and professor of education at Cardiff Metropolitan University. Professor Beauchamp moved into higher education as a lecturer at Swansea University. Professor Beauchamp has also published work on ICT and interactive teaching, primary education, music education and primary school science education.

Dr Michael Beverley is a lecturer at Bangor University and director of undergraduate studies. He organises and teaches educational applications of Behaviour Analysis; he has conducted training in Precision Teaching in the UK, Spain, Italy and Norway. His research is focused on improving basic skills education in mainstream schools.

Dr Anna Bryant (née Leyshon) is Programme Director for sport and physical education at the Cardiff School of Sport. Her PhD (completed in 2011) was funded by Sport Wales and focused on young people's leisure lifestyles and their engagement with the '5x60' programme in secondary schools across Wales.

Professor Dan Davies is Professor of science and technology education and dean of Cardiff School of Education at Cardiff Metropolitan University, a position he has held since January 2015. He holds a BSc in physics, MA in design and technology education and PhD in the relationship between science and technology in the primary curriculum. He started his career as a primary teacher in south London, before working for the Design Council as an education officer and lecturing in science and technology education at Goldsmiths' College and Bath Spa University.

Dr Geraint Davies is a senior lecturer in Initial Teaching Training at the South West Wales Centre of Teacher Education and within the School of Theology, Religious Studies & Islamic Studies in the University of Wales Trinity Saint David. He is also a tutor for the Farmington Institute, Oxford. Dr Davies has published widely on matters relating to religion, worship and education.

Professor Scott Fleming is the director of research and graduate studies at Cardiff Metropolitan University. Previously based in the Cardiff School of Sport, he has a background in physical education and the sociology of 'race relations' but his most recent research has been concerned with inter-disciplinary approaches to understanding organisations.

Dr John Graystone was chief executive of ColegauCymru until 2014, representing further education (FE) colleges in Wales. There he worked with the Welsh Government and other key bodies, serving on various committees and working groups and conducting research and consultancy. He has taught in schools and further and higher education. John has published widely, particularly on post-16 educational policy, FE governance and adult learning. He currently chairs an awarding body and an FE institution and serves on several governing bodies.

Professor Richard Hastings is a professor of education and psychology at the University of Warwick. His research focuses on the fields of special educational needs and disability across the lifespan, and on the evaluation of psychological interventions in educational contexts.

Dr Kieran Hodgkin is a lecturer in education studies within the School of Education at Cardiff Metropolitan University. Kieran completed his PhD in July 2014. His research centred on pupils' expectations and experiences of the primary-secondary transition with a specific focus on physical education.

Dr J. Carl Hughes is a consultant behaviour analyst at the School of Psychology, Bangor University and director of the Wales Centre for Behaviour Change. He is the deputy head for teaching and learning of the College for Health and Behavioural Science. His research interests include evidence-based educational interventions, including the application of behavioural psychology.

Dr Sioned Hughes is a senior lecturer in Initial Teaching Training at the South West Wales Centre of Teacher Education. She has published many

educational materials, especially in primary geography, including *Teaching Primary Humanities* (Harlowe: Pearson Education, 2013). Her work on Patagonia was recognised by the Welsh Books Council as the ‘Bestselling Children’s Book’ in 2011.

Dr Amy Hulson-Jones is a post-doctoral researcher at the School of Psychology, Bangor University. Amy has a special interest in the use of evidence-based educational methods to improve the literacy skills of children at risk of academic failure. Amy is currently pursuing teacher training and aims to marry research and practice to improve learning in schools.

Dr Sofya Lyakhova holds a PhD in mathematics from the University of Bristol and a PGCE from Swansea Metropolitan University. Prior to returning to teaching mathematics she worked in industry for technology companies. Since 2010 Sofya is the programme leader for the Further Mathematics Support Programme Wales based in Swansea University.

Dr Andrew Neate gained his PhD in mathematics from the University of Wales Swansea, working in the field of stochastic analysis. Following this he worked in the insurance industry but returned to Swansea University in 2007 as a lecturer in the mathematics department.

Dr Howard Tanner is Reader in education at University of Wales Trinity Saint David, where he manages research students in education. Previously he led the secondary mathematics PGCE course in Swansea for twenty-five years following a successful career in mathematics teaching. His PhD was on the teaching of problem solving.

Dr Emily Tyler is a lecturer in both the School of Education and the School of Psychology at Bangor University. Her research interests include the use and evaluation of evidence-based educational interventions in mainstream and special schools, and the effects and challenges of implementation fidelity in school settings.

Dr Richard C. Watkins is a school improvement adviser for the Regional School Effectiveness and Improvement Service for North Wales (GwE) and is an honorary research officer at Bangor University. Richard’s work and research interests include science education and the application of evidence-based teaching strategies in schools.
