Dr Rhian Barrance is a research associate at the Wales Institute for Social and Economic Research, Data and Methods (WISERD) at Cardiff University. She works on the WISERD Education multi-cohort study.

Hannah Burch is a leadership development officer at Teach First Cymru. She completed her MA in leadership at the Institute of Education (University College London) in 2015, writing a thesis that explored the role of vision as a bridge between idealism and reality for early career teachers. Hannah has worked as a secondary school French and Italian teacher and is an alumnus of the Teach First leadership development programme.

Professor Brian Caldwell is principal consultant at Educational Transformations and professor emeritus at the University of Melbourne where he is a former dean of education. He was the first person to be appointed to a personal chair in education at this university. Previous academic appointments include dean of education at the University of Tasmania. He has held teaching and leadership appointments in schools in Victoria, Australia and Alberta, Canada. He has served as the president of the Australian Council for Educational Leaders (ACEL) and as deputy chair of the boards of the Australian Council for Educational Research (ACER) and the Australian Curriculum, Assessment and Reporting Authority (ACARA).

Dr Carol Campbell is associate professor of leadership and educational change and co-director of the knowledge network for Applied Education Research (KNAER) Secretariat at the Ontario Institute for Studies in Education (OISE), University of Toronto. Carol is an appointed education advisor to the premier and the minister of education in Ontario, a member of Wales Education Commission and also of the International Council of Education Advisers to the first minister and deputy first minister in Scotland. Carol's recent co-authored books are: *Teacher Learning and Leadership: Of, By and For Teachers* (Routledge), *Empowering Educators in Canada* (Jossey-Bass) and *Empowered Educators: How High-Performing Systems Shape Teaching Quality Around the World* (Jossey-Bass).

Dr Mark Connolly is an educationalist with experience working in a variety of institutional and cultural contexts. At present he lectures in the School of Social Sciences at Cardiff University in relation to areas of research interest including professional identity, children's rights, risk and outdoor education, and education and cultural policy.

Arwel George began his career as a mathematics teacher at Ysgol Gyfun Rhydfelen in 1972 and was subsequently head of mathematics at Ysgol Llanhari between 1974 and 1984. He served as HMI for five years before being appointed headteacher of Ysgol Gyfun Penweddig in Aberystwyth where he remained until his retirement in the summer of 2009. Professor Toby Greany took up post as professor of education at the University of Nottingham in autumn 2018.
